SECTION 4 - FIRST-AID MEASURES

Description of First Aid measures:

- Inhalation: Move to fresh air and keep at rest in a position comfortable for breathing. If experiencing respiratory problems, seek medical attention.

SECTION 5 - FIRE-FIGHTING MEASURES

Suitable extinguishing media: Water fog or fine spray, alcohol-resistant foam, dry chemical or carbon dioxide fire extinguishers. **Unsuitable extinguishing media**: Direct water stream may cause frothing, splattering of burning material and spreading of fire.

Specific hazards arising from the chemical: Material may be ignited only if preheated to high temperatures (such in fire conditions). Fire in vicinity poses risk of pressure build-up and rupture. SECTION 6 - ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures: Keep unnecessary and unprotected personnel from entering. Ensure adequate ventilation/exhaust extraction. Avoid breathing vapors or mist during clean up. Use protective equipment as described in Section 8. Do not touch or walk through spilled material; spilled material maycause a slipping hazard.

Environmental precautions: Prevent from entering into soil, ditches, sewers, waterways and/or groundwater. Inform the relevant authorities if the product has caused environmental pollution. See Section 12 for more details.

Methods and materials for containment and cleaning up: Remove mechanically; cover the remainder with non-combustible absorbent material (e.g. sand, earth, vermiculite or diatomaceous earth). Precautions for safe handling: Protect chemical from atmospheric moisture. Avoid prolonged exposure to heat and air. Keep away from sources of ignition. Do not reseal if contamination is suspected.
