

# **Polymer Concrete Accelerator Data Sheet**

# **DESCRIPTION:**

Polymer Concrete Accelerator speeds up the drying time of Polymer Concrete 1/4" stamping. Recommended for use when temperatures are below 65° F (18.3° C), in shaded areas or for indoor jobs.

# **FEATURES & BENEFITS:**

- Accelerates drying time for concrete in low temperatures, shaded areas or indoors
- Allows the spreading and stamping crew to work closer together (within 200 300 sq. ft. (18.6 27.9 sm) of each other) and decreases the amount of unstamped material spread ahead of the stamping crew

#### **APPLICATION INSTRUCTIONS:**

Once a surface has been patched, cleaned, dried and prepped for concrete begin mixing Concrete Solutions Stamp-Top. Using a drill mixer, mix 1 gallon (3.8 liters) of water, colorpaks (optional) and 2 - 4 oz of Concrete Polymer Accelerator. At your own discretion, add more or less Concrete Polymer Accelerator to adjust the drying time for your stamping conditions. Add in entire Stamp-Top bag mix and mix for 3-5 minutes. The Stamp-Top mix consistency will vary depending on ambient temperatures and humidity. If needed, add up to 1 quart (1.1 liters) of additional water per bag mix.

Polymer Concrete Accelerator is available in 25 lb pails.
